## Supervised lunches, afternoon and after-school childcare

Staff with socio-educational training supervise the children in rooms specially arranged for this purpose at five different locations. The supplementary childcare services for school children, SEB, are organized in three modules per day, from Monday to Friday, during term-time. At the Weiermatten location only supervised lunches are available, but after lunch the children can be cared for at one of the other locations.

Lunch is delivered to all the locations. Help with homework is included in the care services of modules 2 and 3. An all-day camp is available for a maximum of 11 weeks of the school vacations.

## Registration and organization

Attendance at a SEB is only possible with a binding registration for an entire school term. Each of the modules can be attended individually and for between one and five days a week. The registration of at least five children per location and module (or per day of vacation camp) is required for these childcare services to be provided.

In the case of the vacation camps, a child has to be registered for the entire day. The children have to be able to make their own way to the SEB. Any transport costs are to be covered by the parents/legal guardians.



## Costs

This range of childcare services is subsidized by the municipality of Reinach for children who are resident in Reinach. The contribution of the parents/legal guardians to the costs of the childcare is determined on the basis of their income level. The relevant income is determined on the basis of the data submitted to our fiscal administration. Calculations are made according to the Regulations Governing Supplementary Childcare.
